465 hexaconazole

Dear Colleague,

This is to inform you that Rallis India Ltd. is planning to organise a full scale collaborative trial on a method for hexaconazole.

Principle: The content of hexaconazole in formulations is determined by reversed phase high performance liquid chromatography on a 250 x 4.6 mm (i.d.), 5 μ m C18 column, with mobile phase composed of acetonitrile/water/methanol (70/40/10 v/v) and UV detection at 230 nm. Quantitation is done by external standardisation.

Scope: It is intended to analyse six samples consisting of two technical materials (TC), two water dispersible granules (WG) and two suspension concentrates (SC). Samples and hexaconazole analytical standard will be supplied.

Time schedule: The collaborative trial is intended to be carried out during Aug 2018- Oct 2018 (shipment in last week of Aug 2018). Those who wish to participate should contact the organiser by 25th August 2018. The results should be reported by the end of October 2018.
